Dear Mr. Dritsakos,

The Federal Air Transport Agency of the Russian Federation (FATA) would like to present its compliments to the Hellenic Civil Aviation Authority, to you personally and to thank you for your letter dated March 19<sup>th</sup>, 2021.

As we advised you earlier, we consider the restoration of international regular and charter flights as an essential measure in supporting the civil aviation, while this process should strictly adhere the approved health safety instructions and recommendations for travelers, passengers and staff. As such, we pay much attention to the current situation with the novel corona virus and highly value the efforts that Government of your country makes to reduce the risks of further contamination of hazardous COVID-19 and to secure that the epidemiological conditions remain favorable and stable.

At the same time we would like to remind you, that for the present time, the right of restoration of the international flights and/or the increasing the number of flights operated between the points in the Russian Federation and points in the other foreign States belongs to the Emergency Response Center to Prevent the Spread of the Novel Coronavirus in Russia of the Government of the Russian Federation (hereinafter - Emergency Response Center) only.

So, unfortunately, without such a decision we are not able to permit those flights now.

As soon as any news from Emergency Response Center will be received by the FATA - we will do our best to inform you accordingly.

The Federal Air Transport Agency of the Russian Federation avails itself of this opportunity to renew to the Hellenic Civil Aviation Authority the assurances of its highest consideration, hopes for your understanding and looking for the further co-operation in future.
